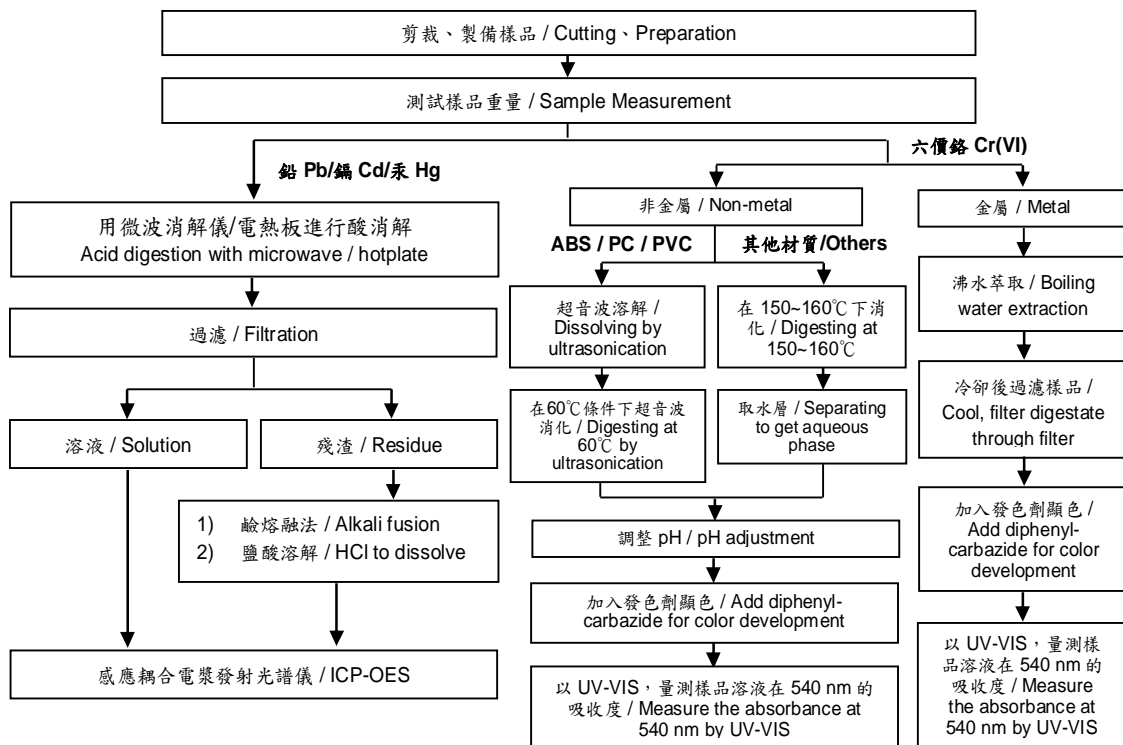

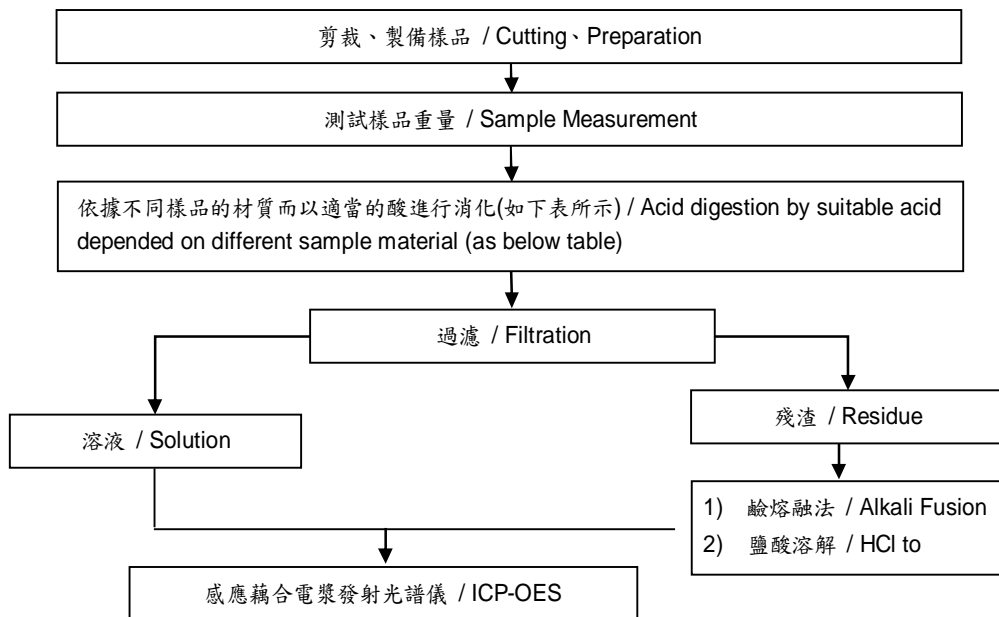

(Flow Chart of digestion for the elements analysis performed by ICPOES)



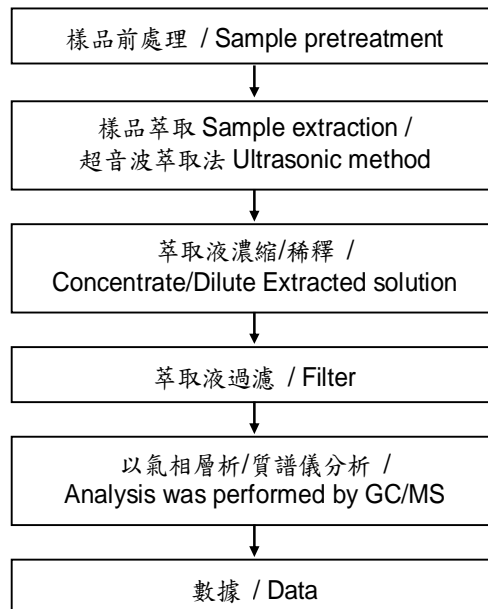

### 六溴環十二烷分析流程圖 / HBCDD analytical flow chart

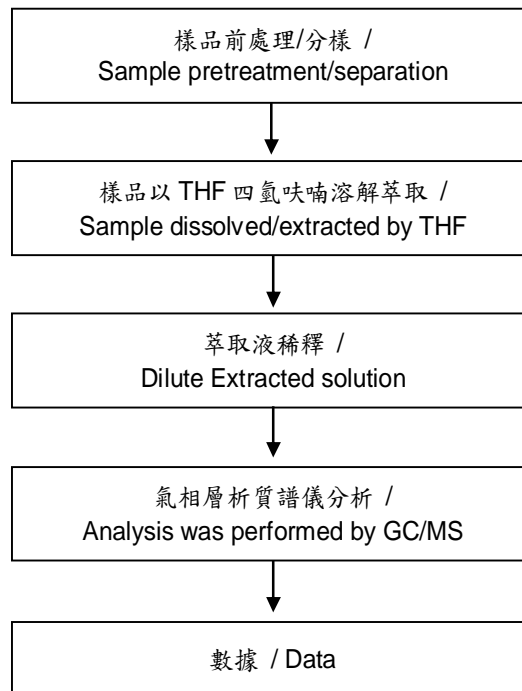

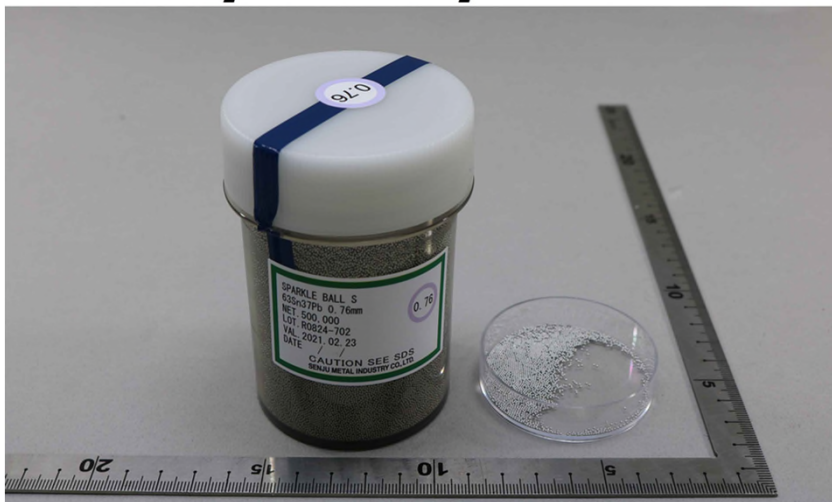
