The part numbers listed below have been qualified to be transferred from R42D, 0.35 $\mu$  process, to R52D-5R, a 0.25 $\mu$  process in Cypress's Bloomington, MN, Fab 4. This will result in a die shrink. The new die revision is C and is marked on the device after the date code.

The ordering part number has been revised to contain the letter "B" (i.e.- CY7C1049B-12VC) in the part number to designate the die shrink. New datasheets have been issued to reflect the part number change and can be downloaded from the following link:
